The necessity and importance of providing civil legal aid are clear from two studies released by Indiana's Coalition for Court Access. The [Indiana Civil Legal Needs Study](#) and the [Economic Impact and Social Value Return on Investment Analysis](#) provide insight for allocating civil legal aid resources and the return on investment for the State of Indiana when civil legal needs are met for low-income Hoosiers.
