Ice Miller Hosts HSE Mock Trial Team, Team Places 2nd in National Competition

Attorneys at Ice Miller LLP watched a 30-minute abbreviated trial by the Hamilton Southeastern High School team on July 25. What did the litigators learn? That Indiana has top-notch high school students in its High School Mock Trial program. Attorneys praised the students' abilities to examine witnesses and focus on core facts in a case they had learned in the previous seven weeks.

Janet Chandler, the team coach and a Foundation board member, had her students demonstrate an opening statement and direct examination of a witness, and the students explained the multiple roles they filled on the team.

Many thanks to Rich Thrapp, board member and host, Janet Chandler, the HSE team, and the attorneys who attended this presentation. The team placed second at the National Judicial Competition, sponsored by the YMCA, and will compete in Indiana's High School Mock Trial program in February 2018.

"I have been involved in the *We the People* program since I began teaching the course at Homestead High School in 1997. I taught the class and competed in district (now regional) and state competitions for 19 years until I retired in 2016. After retirement, I became the coordinator for the northeast regional.
