## We the People State Finals Results



Nearly 600 students competed at the We the People State Finals December 8-10. Cathedral High School won the competition and will represent Indiana at the national finals. Fishers Junior High School took first place at the middle school competition.

Finishing in second and third place at the high school level were Fishers High School and Hamilton Southeastern High School, respectively. At the middle school competition, Fall Creek Junior High finished second, and Brown County Junior High School won third place.

The We the People educational model has been shown to [increase civic participation](#), including voting rates, for students as they become adults. The model is one of the most effective for creating informed citizens who vote at higher rates than their peers.

Since launching at the end of 2018, the [Indiana Legal Help website](#) has made significant progress in vetting and posting helpful resources for Hoosiers looking for legal help. The website includes a guide to pro bono and civil legal aid organizations, self-help forms, and links to basic legal information.
