New Website Launched



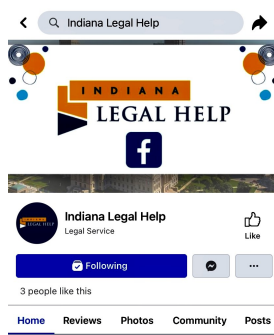
