Justice Steven David reminded the audience that there were only 56 people in Philadelphia to create the Constitution, and that by looking around the room of more than 200, Indiana had "momentum" in its favor. "Right will prevail," he said alluding to the task of increasing access to justice in Indiana.

ISBA President Andi Metzel pledged the ISBA's support for access to justice as well. Brandon Cosby, Executive Director of Flanner House, shared an inspirational message about the impact that one person had on his life by taking an interest in him and guiding him towards a successful career and life. He encouraged the legal aid community to continue helping the marginalized and disenfranchised to realize that "this [justice] system is for you, too."
