### Hon. Larry J. McKinney



On September 21, the U.S. District Court announced the Honorable Larry McKinney had passed away. Judge McKinney served on the U.S. District Court for the Southern District of Indiana since 1987 and was an absolute champion for civic education. He was a member of the Foundation's Citizens Education Advisory Committee and a former board member. He served as a judge for the championship round of the Mock Trial State Finals since the Foundation assumed responsibility of the program in 2014. He absolutely loved watching young people display their trial skills and often commented that the students were better than some attorneys who practiced in his court.

Judge McKinney also presided over the Immigration Naturalization Ceremony each year at the *We the People* State Finals. Not only did he judge the state finals, he also spoke to the *We the People* students
