Coalition for Court Access Conference

On November 2, the CCA is hosting a statewide conference (5 CLE credits) intended for legal aid providers, pro bono lawyers, law school clinics, members of the judiciary and Court staff, and everyone else who provides legal help to low and modest means people in Indiana.

Plenary speakers include Indiana Supreme Court Chief Justice Loretta Rush and Attorney/Advocate Mark Nicholson. Mr. Nicholson is believed to be the only lawyer in modern Indiana history to be admitted to the bar with a major felony conviction. His own criminal history led him to the Indiana State Public Defender's Office, where he worked for five years.
