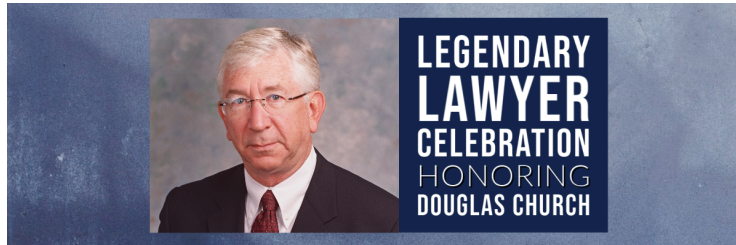
CCA Conference Registration Open
